

**ORDINANCE NO. 19- 03**

**AN ORDINANCE OF THE CITY OF COMMERCE, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY, BY AMENDING APPENDIX A – ZONING, IN PART, BY AMENDING PART II. USES, SECTION 10. – USE OF LAND AND BUILDINGS, SUBSECTION 10-210 RETAIL SALES USE, TO ALLOW ELECTRONIC CIGARETTE ESTABLISHMENTS IN NEIGHBORHOOD SERVICE DISTRICTS, GENERAL BUSINESS DISTRICTS, CENTRAL AREA DISTRICTS, HEAVY COMMERCIAL DISTRICTS, INDUSTRIAL DISTRICTS, PLANNED DEVELOPMENT DISTRICTS, AND CORRIDOR DISTRICTS, AND BY LIMITED USE IN A2 APARTMENT DWELLING DISTRICTS; AND, PROVIDING AN EFFECTIVE DATE.**

A regular meeting of the City Council of the City of Commerce, Texas, was held in Commerce, Texas, at City Hall, on the 18<sup>th</sup> day of December 2018 at 6:00 p.m., a majority of Council Members being present and constituting a quorum, the following Ordinance was adopted:

**WHEREAS**, the Planning and Zoning Commission of the City of Commerce, Texas, in accordance with Section 10-601 of the Zoning Ordinance of the City of Commerce, Texas, conducted a public hearing on December 4, 2018, and all other prerequisites relating thereto, for the consideration of establishing a new zoning use to allow Electronic Cigarette Establishments within certain zoning districts within the City of Commerce;

**AND WHEREAS**, the Planning and Zoning Commission of the City of Commerce, Texas, after conducting the public hearing and considering the nature and described performance of the proposed use and its compatibility with the uses permitted in the applicable zoning districts, voted unanimously to recommend approval to establish a new zoning use for Electronic Cigarette Establishments;

**AND WHEREAS**, the minutes of the City of Commerce, Texas, Planning and Zoning Commission meeting of December 4, 2018, are attached hereto, marked Exhibit “A” and made a part hereof as if copied herein verbatim; and,

**AND WHEREAS**, the City Council, after having reviewed the action of the Planning and Zoning Commission and its recommendation, as well as having complied with all prerequisites of the Zoning Ordinance of the City of Commerce, Texas, relative to establishing a new zoning use, deems it in the best interest and general welfare of the City of Commerce that said new zoning use should be approved.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COMMERCE, TEXAS:**

That the Zoning Ordinance of the City of Commerce, Texas, duly passed by the governing body of the City of Commerce on the 15<sup>th</sup> date of April, 2003, as heretofore amended, be, and the same is hereby amended by amending Appendix A – Zoning, Part II. Uses, Section 10. – Use of Land and Buildings, Subsection 10-210 Retail Sales Use, in part, to allow

Electronic Cigarette Establishments in Neighborhood Service Districts, General Business Districts, Central Area Districts, Heavy Commercial Districts, Industrial Districts, Planned Development Districts, and Corridor Districts, and by Limited Use in A2 Apartment Dwelling Districts, to read as follows:
